Opening

Sam opened the meeting at 1532 with prayer.

Review of Minutes

May minutes were approved by the committee.

FY22 Contributions: May and FY22 to date (Iain)

Dashboard Financial overview provided before meeting and shared on screen during meeting

- Individual giving 87% over budget for the month of May and 23% over budget of YTD
- Corporate giving 10% under budget for the month of May and 4% over budget for YTD
- Grants 3880% over budget for the month of May and 13.3% over budget for YTD
- We are 13% over total budget for YTD
- Paul asked how we got 3,880% over budget on the grants line
 - Iain let the committee know that the grants line is made up of \$1,250 from the Capacity Building Grant as well as \$10,000 from the Home Depot Foundation, and \$40,000 from FHLB. There was a \$1,500 processing fee taken out of the \$40,000 grant. This funding hit the banks account on a different month than anticipated, which is the reason for the large variance.
- Iain let the committee know that the Board approved the FY23 budget. FY23 begins July 1st
- Iain informed the committee that he does not foresee the Religious/Community line correcting itself.
 - Chloe will get the chance to begin fundraising on July 1st

La Rosa Fundraiser (Emma)

- La Rosa Fundraiser that was scheduled for June 12th has been postponed to sometime in August due to a lack of RSVPs.
- Committee has been asked to get the word out and let people know about this fundraiser.
- The meal will include five courses, with a tequila paired with each course.
 - \$75 per person
 - 4:30-6:30 PM (date coming soon)

The Ridge at Sand Creek Community Celebration (Iain)

- June 17th 11:45-1 PM
- The bench is engraved and ready to be unveiled
- This event is to thank LeRoy Landhuis and Love In Action for the largest donation this affiliate has ever seen \$1.75 million worth of land, and also to demonstrate to others that Habitat housing can coexist in mixed neighborhoods

 - Iain highlighted that we will be unveiling the FY22 Year in Review during this event
 - Sam suggested providing some instruction to board members on how to conduct the conversations they might have with donors. The board did this prior to the DAE in 2019 and found it helpful.
 - Paul volunteered to lead this exercise among board members at the August board meeting.
 - Karla reminded everyone that this suggestion must go through the executive committee first before it can be added to the agenda for the board meeting. Karla will add it to the agenda for Ex Com so that it can get approved for the August board meeting
 - Iain let the committee know that roughly a week before the DAE we will send some bullet points directly from the year in review that the board/committee can use as talking points with donors throughout the event. This information will not be ready in time for the August board meeting, but we will make sure to get it out before the event.
 - Karla explained that the board will now meet six times a year, every other month. This is to allow board members to focus more in committees
